Description:

JCM has two styles of EPROMs available for purchase. The Master EPROM comes with a site specific license allowing the purchaser to make copies for the entire site. The copy EPROM is available for customers who cannot duplicate their own software due to technology or regulatory limitations.

Details:

JCM has specifications that must be met to minimize the risk of communication issues. The 512k EPROM used in our units must be 150 nanoseconds or faster. 1Mb EPROM must be 120 nanoseconds or faster. The 4Mb EPROM must be 90 nanoseconds or faster. If you decide to duplicate your Master EPROM software, make sure your EPROMs meet these minimum specs.
