UNUSUAL FIRE AND EXPLOSION HAZARDS

### ROUTES OF EXPOSURE

EFFECTS OF OVEREXPOSITE

Irritation of eyes, skin and respiratory system. May cause nervous system depression. Extreme overexposure may result in unconsciousness and possibly death. SIGNS AND SYMPTOMS OF OVEREXPOSURE

Headache, dizziness, nausea, and loss of coordination are indications of excessive exposure to vapors or spray mists.

Redness and itching or burning sensation may indicate eye or excessive skin exposure. MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE

EMERGENCY AND FIRST AID PROCEDURES

If INHALED: If affected, remove from exposure. Restore breathing. Keep warm and quiet.

If in EYES: Flush eyes with large amounts of water for 15 minutes. Get medical attention. If SWALLOWED:

Prolonged overexposure to solvent ingredients in Section II may cause adverse effects to the liver, urinary, blood-forming, cardiovascular, and reproductive systems

Methyl Ethyl Ketone may increase the nervous system effects of other solvents.

Rats exposed to titanium dioxide dust at 250 mg./m3 developed lung cancer, however, such exposure levels are not attainable in the workplace.

Reports have associated repeated and prolonged overexposure to solvents with permanent brain and nervous system damage.

PRECAUTIONS TO BE TAKEN IN USE

Use only with adequate ventilation. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Wash hands after using.

This coating may contain materials classified as nuisance particulates (listed 'as Dust' in Section II) which may be present at hazardous levels only during sanding or abrading of the dried film. If no specific dusts are listed in Section II, the applicable limits for nuisance dusts are ACGIH TLV 10 mg./m3 (total dust), OSHA PEL 15 mg./m3 (total dust), 5 mg./m3 (respirable fraction). PRECAUTIONS TO BE TAKEN IN HANDLING AND STORING

Contents are EXTREMELY FLAMMABLE. Keep away from heat, sparks, and open flame. Vapors will accumulate readily and may ignite explosively.

During use and until all vapors are gone: Keep area ventilated - Do not smoke -Extinguish all flames, pilot lights, and heaters - Turn off stoves, electric tools and appliances, and any other sources of ignition.

Consult NFPA Code. Use approved Bonding and Grounding procedures.

Contents under pressure. Do not puncture, incinerate, or expose to temperature above 120 °F. Heat from sunlight, radiators, stoves, hot water, and other heat sources could cause container to burst. Do not take internally. Keep out of the reach of children. OTHER PRECAUTIONS
